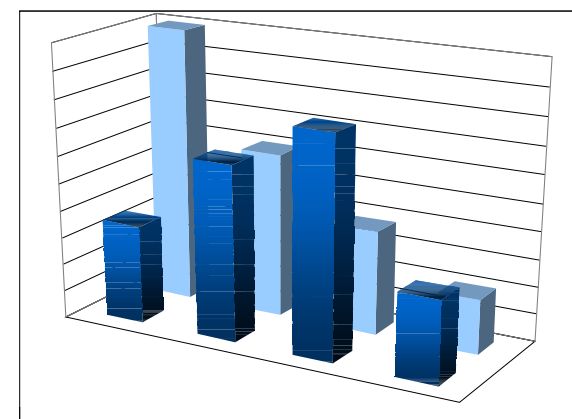

Harmonise the measurements to speed up the improvements of eGovernment services.

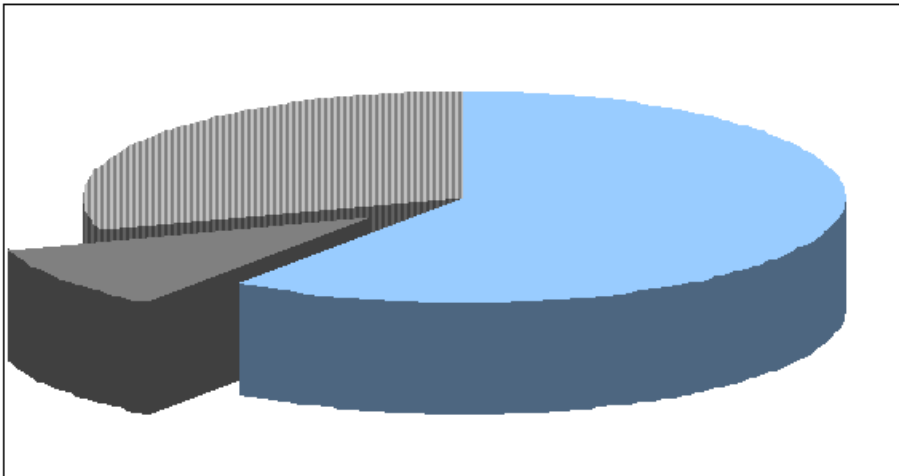

Main features of eGovMoNet.

- Raise the awareness and stimulate uptake of eGovernment impact and user satisfaction measurements.
- Contribute to the harmonisation and quality of measurement frameworks.
- Run five workshops covering a broad range of methodological issues, focused on exchanges of view, best practices and policy discussions.
- Establish a clear base line on the state of the art in eGovernment impact and user satisfaction measurement, including both methods and tools.
- Facilitate policy inputs beside on eGovernment impact and user satisfaction.



How to participate in the network?

We will create a broad and sustainable community across academia, industry, and public agencies, to stimulate and support development, implementation, identification, and re-use of best eGovernment impact and user satisfaction measurement frameworks and tools.
